## **The Consortium of New York Geriatric Education Centers (CNYGEC)**

The Consortium of New York Geriatric Education Centers (CNYGEC) is offering a new 40-hour CME course called The Advanced Course in Geriatrics and Palliative Care for Frontline Primary Care Providers. The vast majority of older adults currently receive their medical care from general primary care providers rather than from geriatrics specialists. By virtue of their practices, most PCPs have a working knowledge of the basic principles of geriatric care. The goal of this course is to provide these seasoned clinicians with advanced training in geriatrics and palliative care using common clinical conditions as a framework for discussion. This interdisciplinary course will employ a variety of learning modalities that are highly interactive and will include hands-on instruction in practical and efficient clinical tools participants can use to improve the care of their older patients. Each day will cover updates on particular disease topics as they relate to geriatrics. Participants will engage in a Commitment to Practice Change and teaching as a result of this course. The course will take place over six months in two different locations. The first training, “Answering Patients’ Questions about Healthy Aging: a State of the Science Update,” takes place November 5, 2009, at the James J. Peters VA Medical Center and November 10, 2009, at The VA NY Harbor Healthcare System, Manhattan Campus.

On November 6, 2009, CNYGEC offers “Creative Arts as a Tool for Improving Quality of Life for Older Adults” at Wagner College, Evelyn L. Spiro School of Nursing. This elective focuses on using art, literature, stories and collage as tools to improve quality of life among older adults.

“Interdisciplinary Team Collaboration and QoL Improvement” takes place on November 13, 2009, at Columbia University School of Social Work and focuses on team development, team management and team maintenance.

“Geriatric Assessment: Try This and How to Try This Series” takes place on December 4, 2009, at the The VA NY Harbor Healthcare System, Manhattan Campus. This course is applicable to all health care providers who provide care to older adults. The course provides an overview of a geriatric assessment and presents several valid and reliable assessment tools that may be used in clinical practice for screening of cognition, nutrition, urinary incontinence, depression and others. The course is presented in a lecture/seminar format that allows participants to discuss actual cases.

“Oral Health: Forgotten Care for Older Adults” takes place on December 10, 2009, at The VA NY Harbor Healthcare System, Manhattan Campus, and will enable healthcare professionals to (1) identify issues associated with oral health of older adults, (2) identify the elements of an assessment of oral health of older adults, (3) identify maintenance best practices concerning oral health care of older adults and (4) identify oral cancer issues and care of older adults.

### **Clinical Pastoral Education (CPE)**

In the spring semester 2010, GEC faculty members Lois Evans, PhD, FAAN, RN, van Ameringen Professor in Nursing Excellence/GEC Co-Director, and Joel Streim, MD, Professor of Psychiatry, will lecture in the Clinical Pastoral Education Series. Their session topics will be “Transitions in Late Life: Challenges Posed by Cognitive Impairment and End of Life” and “Conflict Resolution” respectively.

### **Penn Care at Home**

In this cycle of the grant, the GEC-GP formed a collaboration with Penn Care at Home (PCAH). As a result of planning meetings with the lead of the GEC Palliative Care Committee and the Director of Staff Education at PCAH, the needs of the staff were assessed to develop a three part series of in-service programs focused on older adult patients. The series of lectures will be delivered every two weeks from October to November 2009 by various faculty experts from the Penn community and collaborating organizations. The series will include presentations on “Decision-making Capacity in the Older Adult: Who Decides,” “Polypharmacy in the Older Adult: How to Provide Medication Safety and Error prevention” and “Hospice – What is it? Who is eligible? How to Bring It Up?” Upon completion of the In-Service Program, the series will be evaluated for effectiveness and potential modification for delivery in the spring semester.

### **Wissahickon Hospice**

Through needs assessment developed by the GEC Palliative Care faculty with the Director of Staff Education of Wissahickon Hospice, the needs of staff and focus of educational programming for the monthly staff in-services were evaluated. The needs assessment demonstrated that education should be focused on helping staff understand how to participate effectively as a team member, communication and understanding what skills/knowledge each team member brings to the group in their care for older, frail and dying patients. To this end, monthly interactive educational sessions from September 2009 through July 2010 were created using current complex cases to meet the self-assessed educational needs of the team during the year. In addition, administrator input and quality outcomes are reviewed to determine gaps in training.

For each session of the year long program, presenters from different disciplines and experts from various schools within the university were identified and invited as faculty. Topics and case studies focused on the older adult have been identified and the curriculum has been developed around the following: pain/symptom control, patient/family communication (how to conduct a family meeting, eliciting goals of care), coordination and communication of care through the transition process and preparation and care at the time of death. Pertinent geriatric syndromes as they relate to palliative care have also been incorporated, particularly dementia, delirium and falls. Pre and post tests will be given to staff, and a mid point and end of series evaluation will be administered to determine the effectiveness of the program and potential modifications in the curriculum for the following year.

## Live Oak Geriatric Education Center (LOGEC)

### Applying Train-the-Trainer Experiences in Long Term Care

The Live Oak Geriatric Education Center (LOGEC) is a collaborative effort of faculty at Florida State University, Florida A & M University and the University of South Alabama. Live Oak GEC serves older adults in the Florida Panhandle, South Georgia and Southeast Alabama.

After the 2009 Live Oak Geriatric Education Center's train-the-trainer workshop, GEC faculty and attendees from Rosewood Manor nursing home in Pensacola, Florida, planned and presented three in-services utilizing techniques shared in the workshop. Their goals were to engage staff and empower them to actively contribute to improved care.

At Session One, two well-known concepts were introduced: 1) the "ABCs of behavior management" and 2) the quote, "With dementia, the patient cannot change; therefore, the caregiver must change, and the environment must change." Audience input was lively in suggesting reasons the patient *may* change. Input was organized into a mnemonic device, entitled "DELIRIUM." Staff was encouraged to use "ABC tracking forms" to document observations with specific individual patient Behaviors, recording related Antecedents and Consequences. They were encouraged to organize antecedents around patient, caregiver and environmental factors.

For Session Two, four behaviors were selected from the staff's ABC forms. Each was the focus for small group brainstorming. An unexpected consequence of staff selecting the behaviors (rather than leadership making the selections) was that only one "B" reported was a typical "dementia behavior." The Director of Nursing, Associate Director of Nursing and two GEC faculty (a physician and a social worker) led group discussions on 1) bathing, 2) resistance to care in dementia patients, 3) refusal of care in psych patients and 4) refusal of care in young, dying patients. The groups then shared their potential strategies for improving C by influencing A with these particular Bs.

During Session Three, the staff divided into teams to focus on four QI topics: 1) falls, 2) pain, 3) UTIs and 4) Clostridium difficile infections. Consequences were to be a decrease in each of the conditions. Staff was to consider Behaviors and the Antecedents related to those behaviors. Information collected during the month was organized in the ABC/patient-caregiver-environment format as resource material for new brainstorming groups. At the session, strategies were developed based on the information and additional brainstorming. Findings were again shared between the groups.

The session ended with a brief introduction to continuous quality improvement and the PDCA cycle. Discussion also reflected on the realization that almost all the strategies suggested through brainstorming were ones that would take little if any financial investment to implement. An unanticipated benefit of brainstorming multiple QI needs at one time was demonstration of overlap in applicable strategies for different concerns.

At this time, it is uncertain what impact this approach or any specific strategies developed will have on the facility's staff and patients. The Associate Director of Nursing indicates there is more input from staff now than in the past. He shares, "They are asking questions, bringing up concerns and offering suggestions as they've never done in the past." Follow-up is planned.

### **Pre-Conference Institute: “Evaluating Programs Delivered at Multiple Sites: Integrating Results in a Geriatrics Education Center Context”**
